## **PREAMBLE**

**WHEREAS,** the Karegnondi Water Authority ("KWA") was created pursuant to Act 233 of the Michigan Public Acts of 1955, as amended;

**WHEREAS,** the KWA adopted an Operating Fund Budget for the KWA Fiscal Year 2016-2017 ("FY 16-17 Budget");

**WHEREAS,** when the KWA adopted the FY 16-17 Budget, the budget was based upon KWA providing no water service in the fiscal year;

**WHEREAS**, the Genesee County Drain Commissioner's Office – Division of Water & Waste Services, as County Agency, pursuant to 1939 PA 342 ("GCDC") has requested KWA to furnish it with raw water beginning June 1, 2017;

**WHEREAS**, the request by GCDC for water beginning June 1, 2017 requires that the KWA provide water service during KWA FY 16-17, which further requires an amendment to the FY 16-17 Budget to more accurately state the new revenue and expenditure requirements;

**WHEREAS**, the KWA Board hereby approves the following KWA Operating Fund Budget amendments and authorizes the KWA Treasurer or his/her designee to make the appropriate entries upon the appropriate ledger(s) to reflect the budget amendments; now

**THEREFORE, BE IT RESOLVED THAT:** All of the matters stated in the recitals of this Resolution are true and correct and are hereby incorporated into the body of this Resolution as though fully set forth in their entirety herein.

**NOW, THEREFORE, BE IT FURTHER RESOLVED THAT:** The FY 16-17 Budget shall be amended as set forth on Exhibit A attached hereto and incorporated herein;

**NOW, THEREFORE, BE IT FURTHER RESOLVED THAT:** The KWA Treasurer or Deputy Treasurer is authorized by the KWA Board to amend the FY 16-17 KWA Operating Fund Budget consistent with the amendments set forth on Exhibit A.
